



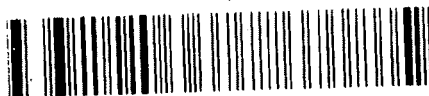



Halal / Halal slaughter Certificates must meet the requirements mentioned in the **Food Importer's Guide** available on the Port health & Food control Section's page - Ministry of Public Health website, especially the information regarding the food consignments and attestations about Halal Certificates.
2. It is recommended to follow up the updates of **This List** to assure the validity of approval before issuing any certificate for the consignments shipped to the State of Qatar.
3. The Ministry of Public Health does not charge any fees for approval.
4. The approved Islamic Centers are fully responsible of the content of Halal / Halal slaughtering Certificates, specially the Halal attestations which must comply with the relevant Technical Regulations / standards.
5. Approval for any Islamic Center is restricted to the geographical area of the country where that center is located. Any branch of that center outside the borders of its country, will be treated as an independent center.
6. Any approved centers in European Union (EU) countries can issue Halal / Halal slaughter certificates within the EU's geographical area, since EU regulations permit freedom of movement.
